# Payslips and P60s 2023

Please note that you only receive a payslip if your current net pay is £2 or more different from the previous pay's period.

Please find below a glossary of the most common pay elements appearing on pension payslips:

**Basic Pension – Pens**: this element relates to the pension you accrued up to April 2014 and remains the same unless reduced by GMPs (see below)

**Basic PI – Pens**: this element relates to the Pensions Increases (index-linking) on the Basic element that occurs each year in line with the Pensions Increase (Review) Order

**CARE Basic – Pens**: this element remains the same and relates to the pension you accrued from April 2014 onwards

**CARE PI – Pens**: this element relates to Pensions Increases on the CARE element each year in line with the Pensions Increase (Review) Order

**GMP – Pens**: Guaranteed Minimum Pension – relates to service under the Local Government Pension Scheme as opposed to the State Earnings Related Scheme. It is offset against the Basic Pension amount

## Life Certificates 2023

As you may be aware, the City of London is required to obtain annual written confirmation from those pensioners who are living overseas that they remain eligible to receive their payments. To enable this, a 'Life Certificate' is issued to each overseas member to be signed and returned to the Pensions Office.

The 2023 certificates were emailed to those pensioners for whom the City holds an email address, with the remainder sent out by post. Pensioners had two months to complete and return the certificate from the date of posting.

Please be aware, this annual exercise is <u>only</u> carried out for those pensioners residing abroad and does not include those who live in the UK.

However, there is an exception to the above that may apply for UK residents.

The City Corporation undertakes regular data matching to prevent and detect fraud, this includes matching City of London pension data against deceased data from the General Records Office (GRO) for the whole of the UK. The City of London uses the services of the National Fraud Initiative (NFI) who provide this service through the Public Sector Fraud Authority for public bodies across the UK.

Once a month, a list of all our current UK based pensioners is matched against GRO records. Should your name appear as a possible match, the City will contact you and ask you to complete a life certificate. You will have two months to return the certificate and if we do not receive it by the end of this period your pension payments may be suspended.

If you do receive such correspondence and are unsure how to proceed, please do not hesitate to contact the Pension Office.
